**AMENDMENT TO MEMORANDUM OF UNDERSTANDING
BETWEEN
THE UNITED NATIONS HUMAN SETTLEMENTS PROGRAMME
AND
PAX
AND
MUNICIPALITY OF VUSHTRRI**

WHEREAS, the United Nations Human Settlements Programme (hereinafter referred to as "UN-Habitat"), PAX (hereinafter referred to as "PAX") and Municipality of Vushtrri (hereinafter referred to as "the Municipality of Vushtrri") and collectively referred to as the "**Parties**" and individually as the "**Party**", concluded the Memorandum of Understanding (hereinafter referred to as the "**MoU**") on 19 April 2018 to jointly collaborate on the implementation of the Project 'Inclusive Development Programme' with a completion date of 30 September 2020 and further amended on 29 October 2020 in order to extend the term of the Agreement for a further twelve (12) months, up to 30 September 2021, is hereby further amended as follows;

The Agreement on the support to the project 'Inclusive Development Programme' between Sweden and UN-Habitat was extended to cover the period through 31st December 2021 to accommodate delays confronted by the programme and to allow completing the Capital Investment Projects co-funded by the CIF as concrete outputs from the planning processes.

The changes are reflected in the amended Article XVIII below.

ARTICLE XVIII

This Amendment shall become effective as of the date of countersignature. All other terms and conditions of the MoU remain valid and enforceable.
