



Announcement of Scholarships 2026-2027

For the University of York Europe Campus in Thessaloniki, Greece

For Citizens of the Municipality of Vushtrri

The University of York Europe Campus in cooperation with the Municipality of Vushtrri of the Republic of Kosovo are offering a number of scholarships to citizens of the Municipality of Vushtrri in the following scheme:

- Seven (7) full scholarships (50% will be covered by the Municipality and 50% will be covered by the University)
- Seven (7) half-fees scholarships (50% will be covered by the University and 50% will be covered by the student)

The scholarships are available for Bachelors, Masters (full-time), and MBA studies starting from the academic year 2026-2027 until the end of the specific academic programme and are clearly described further down on this protocol.

Emphasis will be given to those applicants interested in studying Computers Science.

Under this initiative, the Municipality and the University have both agreed to support tuition of exceptional students who wish to study at the University of York Europe Campus, in Greece and pursue a globally recognized degree of the University of York. The studies will be offered at the Campus in Thessaloniki, Greece.

A. Five (5) full tuition fee waiver scholarships for **Bachelors studies** (4 years of study), according to the following scheme:

50% of the tuition fees will be covered by the University (4,145 Euros per student per year, currently the undergraduate yearly nominal tuition fees are 8,290 Euros)

50% of the fees will be covered by the Municipality of Vushtrri (4,145 Euros per student per year)

50% of the fees will be covered by the Municipality of Vushtrri (8,945 Euros per student)

INFORMATION ON THE PAN-EUROPEAN EXECUTIVE MBA:

- The Pan-European Executive MBA programme is delivered at weekends.
- Duration of the MBA studies: 2 years.
- The programme includes taught classes: one long weekend per month in Thessaloniki or online (in total 8 weekends over 18 months). It also includes 3 study weeks: at the University of York, UK; at the University of Strasbourg, France; and at the University of York Europe Campus, Thessaloniki, Greece.
- Beneficiaries of the scholarships are expected to travel to Thessaloniki on the scheduled weekends and the travelling costs will be covered by the student.
- Scholars are expected to travel to the University of York, UK for one week at the end of the first year of studies; to the University of Strasbourg, France in September of the first year; and to the University of York Europe Campus, Thessaloniki for one week at the end of the second year of studies. The travelling costs for the study trips to York / UK, to Strasbourg / France, and to Thessaloniki / Greece will be covered by the student.

50% of the fees will be covered by the University (8,945 Euros per student, total nominal tuition fees for the Executive MBA are 17,890 Euros)

50% of the fees will be covered by the student (8,945 Euros per student)

INFORMATION ON THE PAN-EUROPEAN EXECUTIVE MBA:

- The Pan-European Executive MBA programme is delivered at weekends.
- Duration of the MBA studies: 2 years.
- The programme includes taught classes: one long weekend per month in Thessaloniki or online (in total 8 weekends over 18 months). It also includes 3 study weeks: at the University of York, UK; at the University of Strasbourg, France; and at the University of York Europe Campus, Thessaloniki, Greece.
- Beneficiaries of the scholarships are expected to travel to Thessaloniki on the scheduled weekends and the travelling costs will be covered by the student.
- Scholars are expected to travel to the University of York, UK for one week at the end of the first year of studies; to the University of Strasbourg, France in September; and to the University of York Europe Campus, Thessaloniki for one week at the end of the second year of studies. The travelling costs for the study trips to York / UK, to Strasbourg / France, and to Thessaloniki / Greece will be covered by the student.

IMPORTANT NOTES

- Upon successful completion of the Bachelors or Masters programmes, graduating students will be awarded the Bachelor's or Master's degree from the University of York, UK
- Upon successful completion of the MBA programme, students will be awarded two (2) MBA degrees: one from the University of York, UK and one from the University of Strasbourg, France
- The scholarships cover the tuition fees and registration fees. Students should therefore cover their travel, accommodation, and their living expenses with their own finances
- If a student-recipient of a scholarship does not attend the programme for any personal or other reason, then a student from the runner-up list will replace him / her, including students with 50% self- financing.
- The Municipality and the University will agree on student replacements also in other cases, whereas the selection of students will be made by the University
- If a student, due to health or other emergency reasons, request temporary suspension of studies, the Municipality will establish a committee to verify the suspension request: the committee will approve or turn down the request based on facts
- The students admitted on condition (i.e. cases pending to receive their diplomas) shall be obligated to submit to the University of York Europe Campus the diploma or diploma certificate the latest by 15 September, otherwise they will be replaced by students in the ranking list, including the students with 50% of self-financing.

ELIGIBILITY FOR THE BACHELORS SCHOLARSHIPS

- The Bachelors studies last 4 years
- Candidates for the Bachelors Scholarships must be Kosovo citizens, officially recorded as residents of the Municipality of Vushtrri and should also meet the admission requirements of the University's programmes for which they are applying
- Candidates eligible for the Bachelors programmes should hold a High School Leaving Certificate (Matura based on the Law) OR are expected to receive their Matura in the summer 2026
- Candidates must have fluent command of the English language (TOEFL: internet based 79 or IELTS: 6,0 or Duolingo: 100 or equivalent qualifications). Candidates who do not possess at the time of the application any of the above mentioned English Language Qualifications are eligible for the scholarships provided that they take the University's English Language Test, which will be organized by representatives of the University in Prishtina before the final selection of the scholars. However, after being accepted to the programme of their interest, the scholars must take the IELTS or TOEFL or Duolingo exams during the first year of studies and achieve the required score (TOEFL: internet based 79 or IELTS: 6,0 or Duolingo: 100 or an equivalent qualification)

ELIGIBILITY FOR THE MASTERS SCHOLARSHIPS

- The Masters studies last 1 year (full-time programme)
- Candidates for the Masters Scholarships must be Kosovo citizens, officially recorded as residents of the Municipality of Vushtrri and should also meet the admission requirements of the University's programmes for which they are applying
- Candidates eligible for the postgraduate programmes are normally expected to hold, or to be about to achieve, a good Class Honours Bachelor's Degree from a University or an accredited college according to the Kosovo Law
- Candidates must have fluent command of the English language (TOEFL: internet based 89 or IELTS: 6,5 or Duolingo: 110 or an equivalent qualification). Candidates who do not possess at the time of the application any of the above mentioned English Language Qualifications are eligible for the scholarships provided that they take the University's English Language Test, which will be organized by representatives of the University in Prishtina before the final selection of the scholars. However, after being accepted to the programme of their interest, the scholars must take the IELTS or TOEFL or Duolingo exams during the first semester of studies and achieve the required score (TOEFL: internet based 89 or IELTS: 6,5 or Duolingo: 110 or equivalent qualification).
- Students who have completed ALL their undergraduate studies through the medium of English Language are not required to present an English Language Qualification.

ELIGIBILITY FOR THE MBA SCHOLARSHIPS

- Candidates for the MBA Scholarships should meet the Admission requirements of the University.
- Candidates eligible for the Executive MBA programmes are normally expected to hold a good Honours Bachelor's Degree from a University or an accredited college according to the Kosovo Law.
- Candidates must have a fluent command of the English language (TOEFL: internet based 89 or IELTS: 6.5 or Duolingo: 110 or equivalent qualifications). Candidates who do not possess at the time of the application any of the above mentioned English Language Qualifications are eligible for the scholarships provided that they take the University's English Language Test, which will be organized by the University's representatives in Prishtina before the final selection of the scholars.
- Students who have completed ALL their undergraduate studies through the medium of the English Language are not required to present an English Language Qualification.
- Significant working experience (of at least three years) is needed, which must be certified.

ENGLISH LANGUAGE TEST

Applicants for scholarships who do not possess any of the English Language qualifications, as set by the University's Admissions Requirements, will be requested to take the University's English Language Test.

This English Test will be organised in Prishtina by representatives of the University of York Europe Campus.
